1. Market overview

- Both RSI and ALSI remained constant to close at 128.78 and 131.20 respectively.
- Today's trading session recorded a total of Frw 7,300,000 worth of bonds traded in 1 deal.
- The equities counters closed as follows: BLR: Frw 150; KCB: Frw 330; BK: Frw 278; CTL: Frw 53; IMR: Frw 91; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

At the end of the formal trading hours, on BK counter there were outstanding offers of 195,000 shares between Frw 278-290 and no bids. On BLR counter, there were outstanding offers of 90,700 shares at Frw 150 and no bids. On CTL counter, there were outstanding offers of 258,000 shares between Frw 53-57 and an outstanding bid of 2,400 shares at Frw 52. On IMR counter, there were outstanding offers of 715,400 shares between Frw 91-97 and no bids.

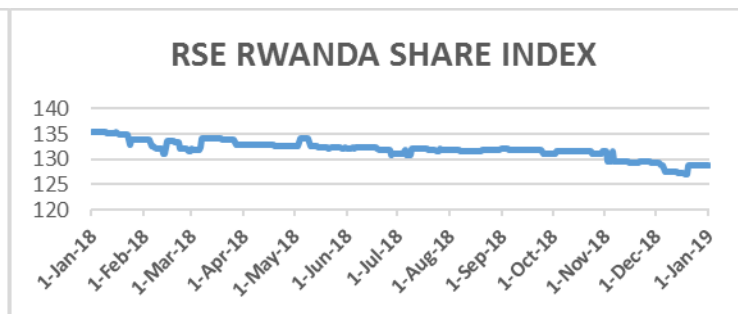
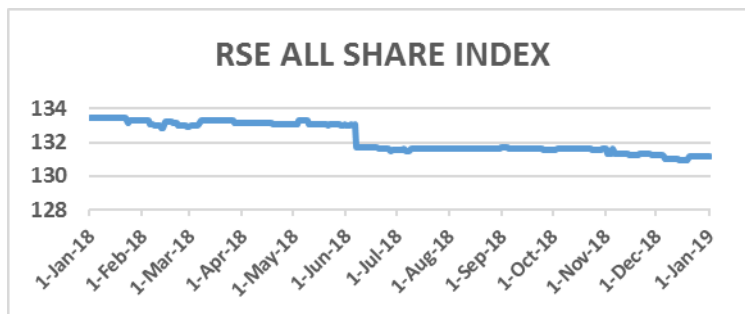
On the bond market, there were outstanding offers of Frw 100,000 worth of bonds at Frw 105 and no offers.
