1. Market overview

- Both RSI and ALSI remained constant to close at 125.92 and 135.99 respectively.
- Today on RSE market both equities and bonds market were quiet.
- Equities counters closed as follows: CTL: Frw 60; BOK: Frw 273 BLR: Frw 143; IMR: Frw 90; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

At the end of the formal trading hours, on BOK counter there were outstanding offers of 110,100 shares between Frw 274-280 and no bids. On BLR counter, there were outstanding offers of 674,600 shares between Frw 142-154 and no bids. On CTL counter, there were outstanding bids of 1,800 shares at Frw 58 and an outstanding offer of 83,500 shares at Frw 65. On IMR counter, there were outstanding offers of 1,034,100 shares between Frw 90-97 and no bids.

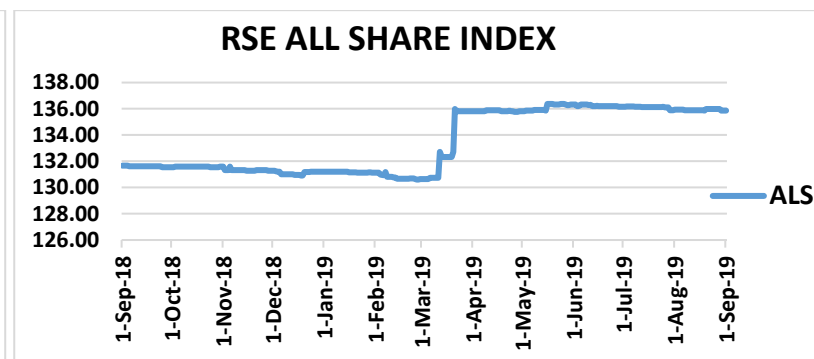
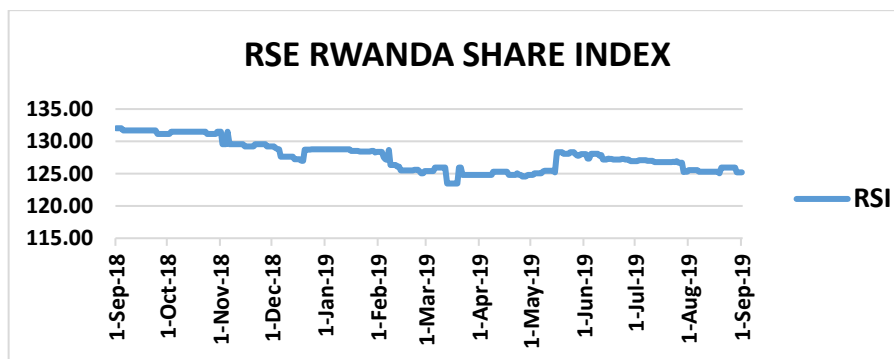
On bond market, there was an outstanding offer of Frw1,000,000 worth of bond at Frw 103.6 and no bids.
