2. Closing bell

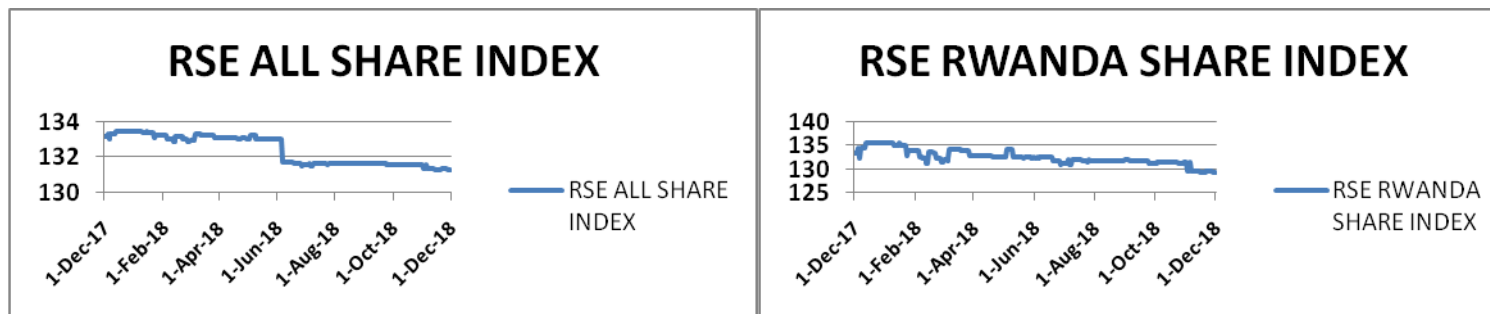
