1. Market overview

- Both RSI and ALSI went down 0.85 and 0.14 point then closed at 127.50 and 130.99 respectively.
- Today's trading session recorded a total of Frw 73,058,400 from 500,400 shares traded in 2 deals and a total of Frw 500,000 worth of bonds traded in 1 deal.
- BLR counter closed at Frw 146 (Frw 149 previous). The trading session recorded total turnover of Frw 73,058,400 from 500,400 shares traded in 2 deals.
- The equities counters closed as follows: CTL: Frw 53; KCB: Frw 330; BK: Frw 278; IMR: Frw 90; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

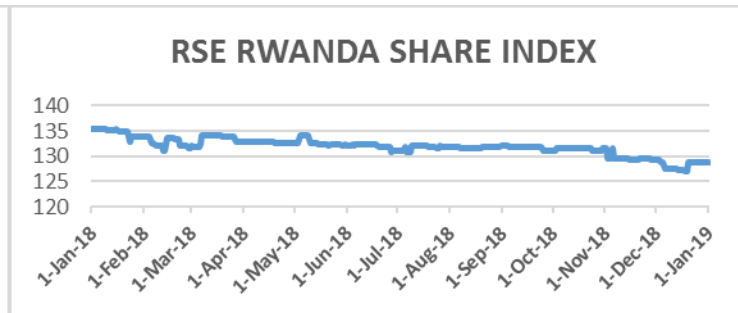
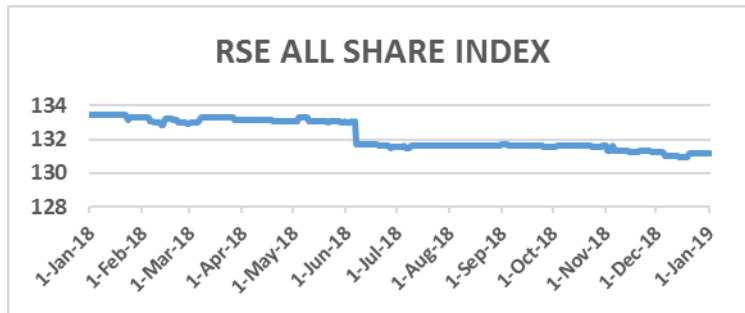
