



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 07TH FEBRUARY, 2019

1. Market overview

- Both RSI and ALSI went up 1.50 and 0.24 point then closed at 128.64 and 131.17 respectively.
- Today's trading session recorded a total of Frw 138,600 from 1,400 shares traded in 4 deals.
- CTL counter closed at Frw 53 (Frw 52 previous). The trading session recorded total turnover of Frw 53,000 from 1,000 shares traded in 2 deals.
- BLR counter closed at Frw 150 (Frw 145 previous). The trading session recorded total turnover of Frw 30,000 from 200 shares traded in 1 deal.
- BK counter closed at Frw 278(Frw 278 previous). The trading session recorded total turnover of Frw 55,600 from 200 shares traded in 1 deal.
- The equities counters closed as follows: IMR: Frw 90; KCB: Frw 330; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

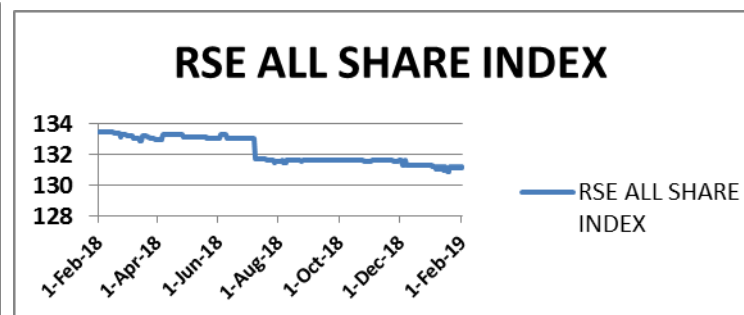
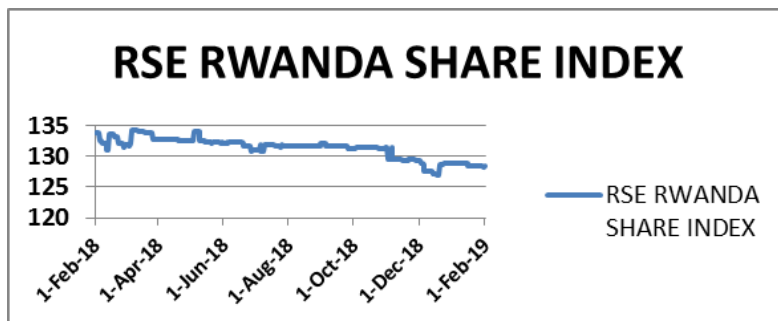
