



## RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 10TH JANUARY, 2019

### 1. Market overview

- Both RSI and ALSI remained constant to close at 128.78 and 131.20 respectively.
- Today's trading session recorded a total turnover of Frw 165,900 from 2,700 shares traded in 4 deals.
- CTL counter closed at Frw 53(Frw 53 previous). The trading session recorded a total turnover of Frw 111,300 from 2,100 shares traded in 3 deals.
- IMR counter closed at Frw 91(Frw 91 previous). The trading session recorded a total turnover of Frw 54,600 from 600 shares traded in 1 deal.

- The equities counters closed as follows: BLR: Frw 150; BK: Frw 278; KCB: Frw 330; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

### 2. Closing bell

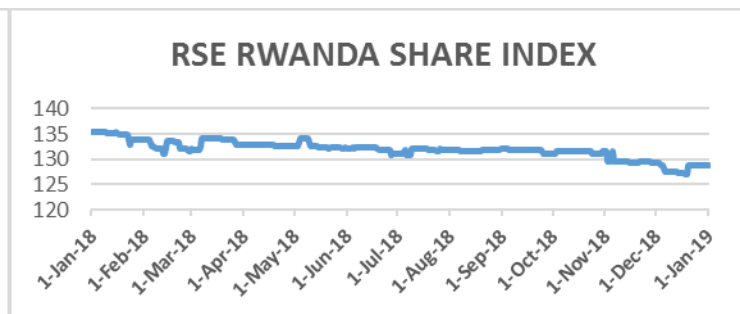
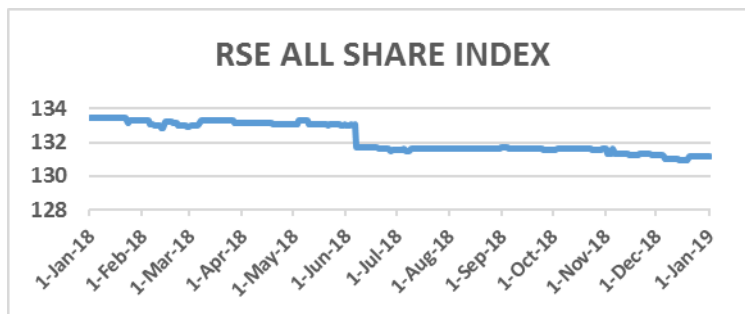
