



RWANDA STOCK EXCHANGE MARKET REPORT FOR THURSDAY 31ST JANUARY, 2019

1. Market overview

- Both RSI and ALSI went up 0.07 and 0.01 point then closed at 128.36 and 131.13 respectively.
- Today's trading session recorded a total of Frw 99,700 from 600 shares traded in 4 deals.
- BK counter closed at Frw 278 (Frw 278 previous). The trading session recorded total turnover of Frw 55,600 from 200 shares traded in 1 deal.
- CTL counter closed at Frw 53 (Frw 52 previous). The trading session recorded total turnover of Frw 5,300 from 100 shares traded in 1 deal.
- BLR counter closed at Frw 149 (Frw 149 previous). The trading session recorded total turnover of Frw 29,800 from 200 shares traded in 1 deal.
- IMR counter closed at Frw 90 (Frw 90 previous). The trading session recorded total turnover of Frw 9,000 from 100 shares traded in 1 deal.
- The equities counters closed as follows: KCB: Frw 330; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

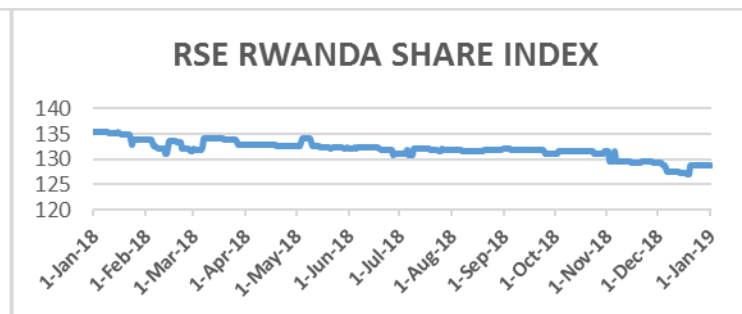
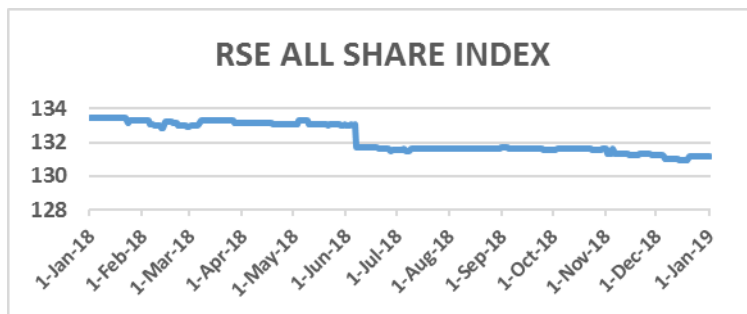
