1. Market overview

- Both RSI and ALSI went down 0.28 and 0.05 point then closed at 127.22 and 130.94 respectively.
- Today's trading session recorded a total of Frw 86,707,300 from 597,400 shares traded in 4 deals.
- BK counter closed at Frw 278 (Frw 278 previous). The trading session recorded total turnover of Frw 166,800 from 600 shares traded in 1 deal.
- BLR counter closed at Frw 145 (Frw 146 previous). The trading session recorded total turnover of Frw 86,540,500 from 596,800 shares traded in 3 deals.
- The equities counters closed as follows: CTL: Frw 53; KCB: Frw 330; IMR: Frw 90; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

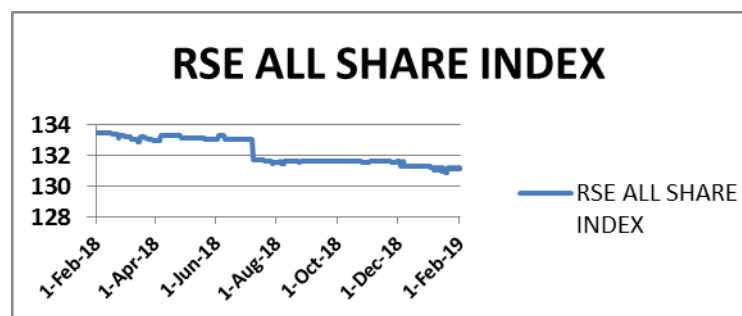
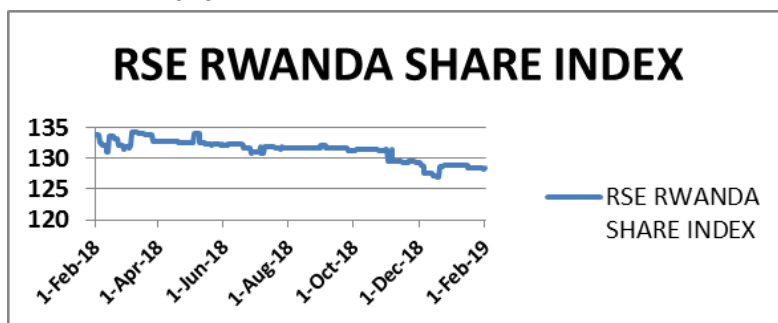
