### 1. Market overview

- Both RSI and ALSI went down 0.28 and 0.05 point then closed at 126.07 and 130.76 respectively.
- Today's trading session recorded a total of Frw 78,960,000 from 560,000 shares traded in 1 deal.
- BLR counter closed at Frw 141 (Frw 142 previous). The trading session recorded total turnover of Frw 78,960,000 from 560,000 shares traded in 1 deal.
- The equities counters closed as follows: IMR: Frw 90; CTL: Frw 53; BK: Frw 278; KCB: Frw 330; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104

### 2. Closing bell

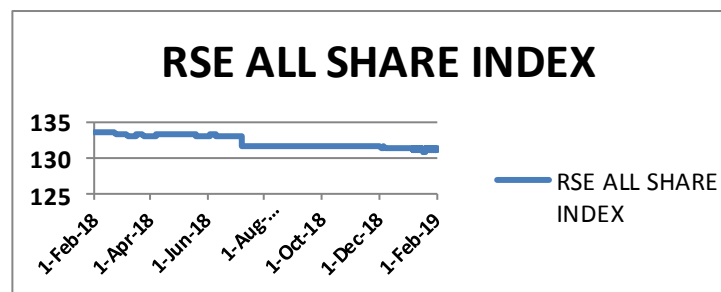
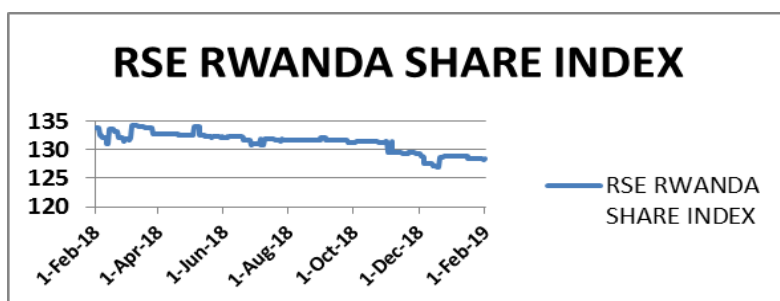
