



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 12TH MARCH, 2019

1. Market overview

- RSI remained constant to close at 125.96 and ALSI went up 1.97 to close at 132.71 respectively.
- Today's trading session recorded a total turnover of Frw 5,089,500 from 18,400 shares traded in 3 deals and Frw 63,500,000 worth of bonds traded in 1 deal.
- CTL counter closed at Frw 50 (Frw 50 previous). The trading session recorded total turnover of Frw 75,000 from 1,500 shares traded in 1 deal.
- IMR counter closed at Frw 90 (Frw 90 previous). The trading session recorded total turnover of Frw 288,000 from 3,200 shares traded in 1 deal.
- KCB counter closed at Frw 345 (Frw 330 previous). The trading session recorded total turnover of Frw 4,726,500 from 13,700 shares traded in 1 deal.

- The equities counters closed as follows: BLR: Frw 144; BK: Frw 275; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

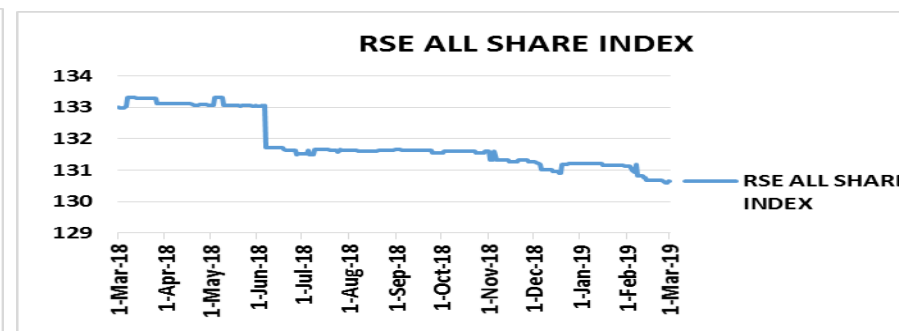
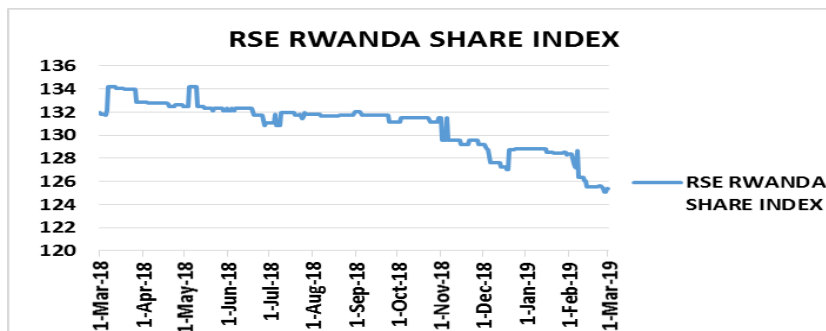
