1. Market overview

- Both RSI and ALSI remained constant to close at 128.50 and 131.15 respectively.
- Today's trading session recorded a total of Frw 14,900 from 100 shares traded in 1 deal.
- BLR counter closed at Frw 149 (Frw 149 previous). The trading session recorded total turnover of Frw 14,900 from 100 shares traded in 1 deal.
- The equities counters closed as follows: CTL: Frw 53; KCB: Frw 330; BK: Frw 278; IMR: Frw 91; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

2. Closing bell

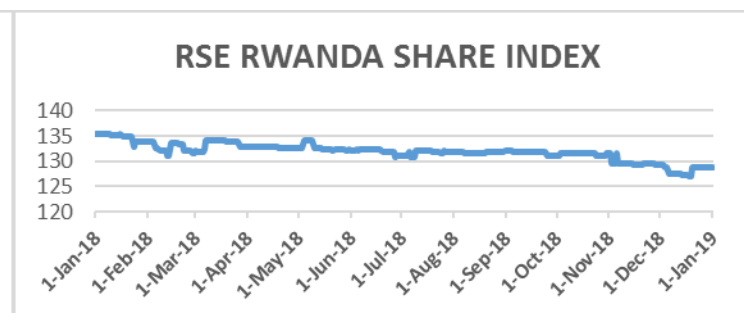
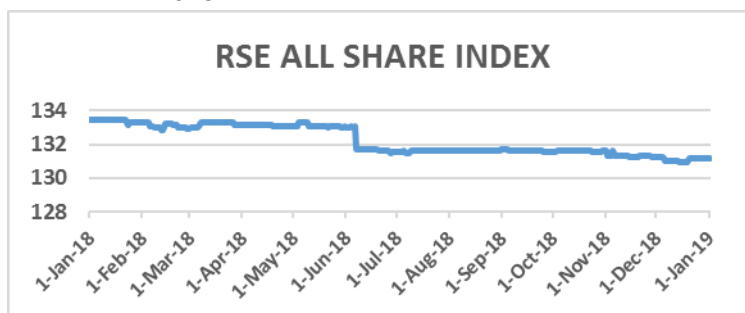
