



## RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 04<sup>TH</sup> SEPTEMBER, 2019

### 1. Market overview

- Both RSI and ALSI went down 0.15 and 0.02 point to close at 126.02 and 136.00 respectively.
- Today's trading session recorded a total of Frw 391,200 from 6,700 shares traded in 2 deals and Frw 13,162,600 worth of bond traded in 5 deals.
- CTL counter closed at Frw 60 (Frw 58 previous). The trading session recorded a total turnover of Frw 391,200 from 6,700 shares traded in 2 deals.
- Equities counters closed as follows: BLR: Frw 143; IMR: Frw 90; BOK: Frw 274; KCB: Frw 370; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

### 2. Closing bell

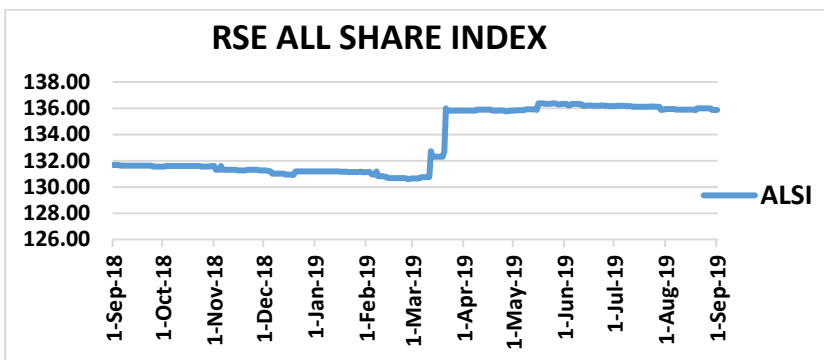
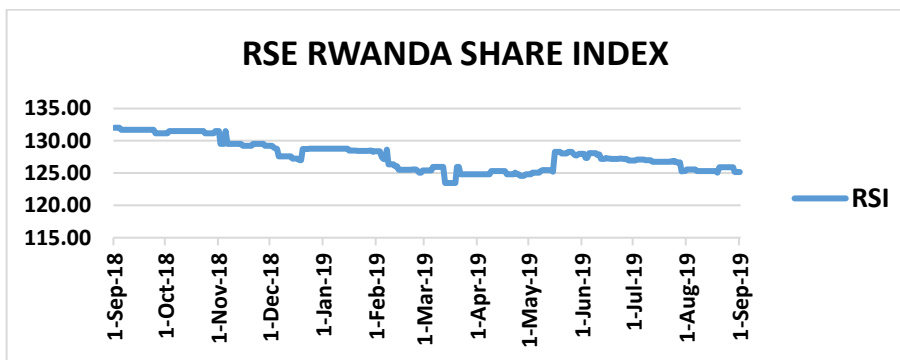
