



RWANDA STOCK EXCHANGE MARKET REPORT FOR WEDNESDAY 30TH JANUARY, 2019

1. Market overview

- Both RSI and ALSI went down 0.21 and 0.03 point then closed at 128.28 and 131.12 respectively.
- Today's trading session recorded a total of Frw 1,305,300 from 11,100 shares traded in 6 deals and a total of Frw 700,000 worth of bonds traded in 1 deal.
- BK counter closed at Frw 278 (Frw 278 previous). The trading session recorded total turnover of Frw 500,400 from 1,800 shares traded in 2 deals.
- CTL counter closed at Frw 52 (Frw 53 previous). The trading session recorded total turnover of Frw 52,000 from 1,000 shares traded in 1 deal.
- BLR counter closed at Frw 149 (Frw 149 previous). The trading session recorded total turnover of Frw 14,900 from 100 shares traded in 1 deal.
- IMR counter closed at Frw 90 (Frw 91 previous). The trading session recorded total turnover of Frw 738,000 from 8,200 shares traded in 2 deals.
- The equities counters closed as follows: KCB: Frw 330; EQTY: Frw 350; NMG: Frw 1200 and USL: Frw 104.

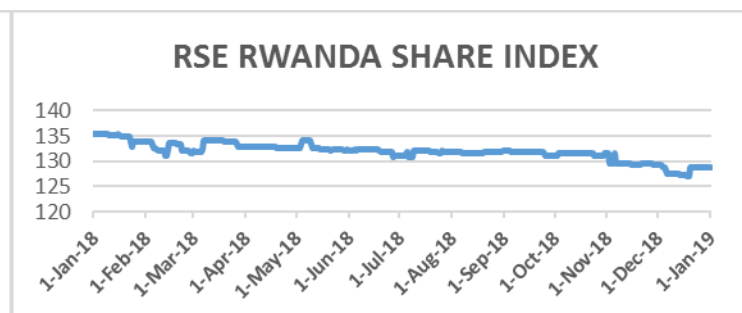
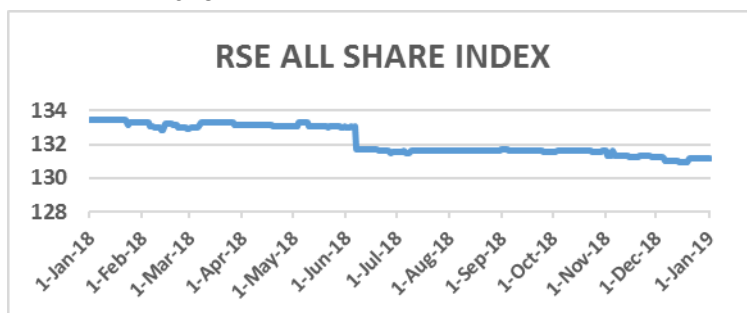
