MAHWI GRAIN MILLERS SECOND TRANCHE BOND LISTING ON RWANDA STOCK EXCHANGE.

Today, October 08th, **2025**; Mahwi Grain Millers Plc, or 'MGM' by trading name, officially listed the Second Tranche of Frw 2,000,000,000 from the Frw 5,000,000,000 approved under the 5-year Note Program on the Rwanda Stock Exchange Bond Market. The bond offer was oversubscribed to with a wide range of investors.
