



RWANDA STOCK EXCHANGE MARKET REPORT FOR TUESDAY 12TH SEPTEMBER 2023

1. Market overview

- Today's trading session recorded a total turnover of Frw 36,487,400 from 130,800 shares traded in 5 deals on the equities market and Frw 300,822,900 worth of Bonds traded in 10 deals on the fixed-income market.
- RSI and ALSI went down to close at 112.97 and 143.69 respectively.
- BLR counter closed at Frw 175 (Frw 175previous). The trading session recorded a total turnover of Frw 105,000 from 600 shares traded in 1 deal.
- BOK counter closed at Frw 290 (Frw 292previous). The trading session recorded a total turnover of Frw 36,364,400 from 129,800 shares traded in 3 deals.
- IMR counter closed at Frw 45 (Frw 45previous). The trading session recorded a total turnover of Frw 18,000 from 400 shares traded in 1 deal.
- Equities counters closed as follows: BLR: Frw 175; BOK: Frw 290; IMR: Frw 45; CMR: Frw 132; MTNR: Frw 170; EQTY: Frw 440; KCB: Frw 328; NMG: Frw 1200; USL: Frw 104 and RHB: Frw 526

2. Closing bell

At the end of the formal trading hours; On MTNR counter, there were outstanding offers of 388,400 shares between Frw 170-174 and no bids. On IMR counter, there were outstanding offers of 264,800 shares at Frw 45 and no bids. On BLR counter, there were outstanding bids of 70,000 shares between Frw 160-165 and outstanding offers of 15,800 shares between Frw 175-180. On BOK counter, there was an outstanding bid of 10,000 shares at Frw 280 and no outstanding offers. On CMR counter, there were outstanding offers of 101,500 shares at Frw 132 and no bids. On EQTY counter, there was an outstanding bid of 200 shares at Frw 440 and no offer. On the bonds market, there was an outstanding offer of Frw 3,000,000 at Frw 102 and no bids.

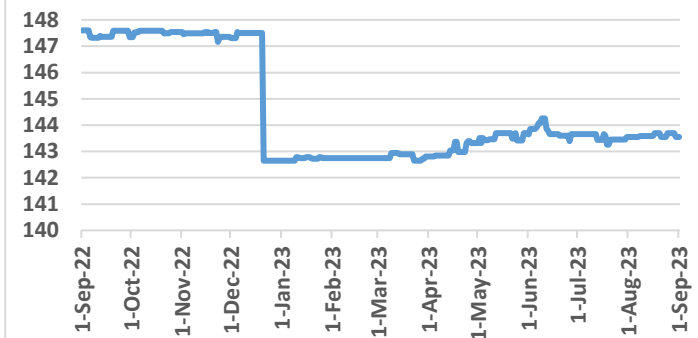

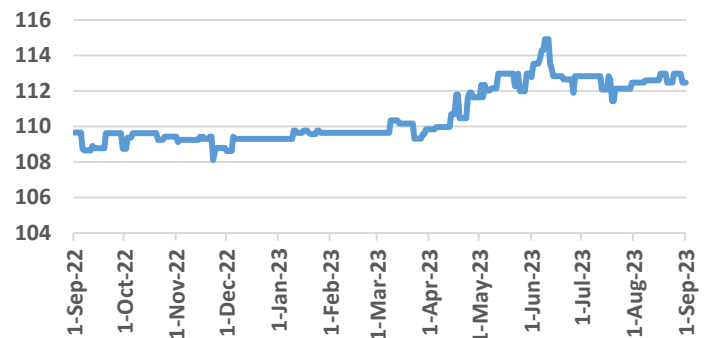
